EDILIZIACROBATICA CONFIRMS THE GROWTH TREND ALSO IN JUNE

The positive series of **EdiliziAcrobatica S.p.A.**, the first Italian company in the double safety rope operating construction sector to be listed on the **AIM segment of the Italian Stock Exchange** and on the European market **Euronext Growth**, continues. In the first 6 months of the year the company recorded increases in sales of its services.

The value of sales of the direct operating offices in the period **January - June 2019 amounted to Euro 23.7 million compared to Euro 14 million in the same period of 2018**, recording an increase of 69%.

The value of sales including franchised operating locations in the period **January - June 2019 amounted to Euro 31.2 million compared to Euro 20.3 million in the same period of 2018**, an increase of 65.2%.

June 2019 recorded a value of sales of direct operating sites equal to Euro 5.2 million compared to Euro 3.4 million in May 2018, an increase of 58.6%.

The value of sales including franchised operating locations recorded in June 2019 was Euro 7 million compared to Euro 4.9 million in June 2018, **an increase of 41.1%**.

As at 30 June 2019, the number of direct operating offices reached 44, an increase of 5 units compared to 39 as at 31 December 2018. As of 30 June 2019, the number of franchised operating offices reached 33, with an increase of 2 units compared to 31 as of 31 December 2018.

"We are very satisfied with the results achieved - **commented Riccardo Iovino and Anna Marras**, respectively CEO and founder of EdiliziAcrobatica, and Director in charge of the Group's human resources - which confirm that the growth strategy adopted, which always focuses on the people who make up our Group, is the right one.
