EDILIZIACROBATICA S.p.A. REVENUES GROW BY +74% IN THE FIRST 3 MONTHS OF 2019

Genoa, 10 May 2019 - Riccardo Iovino, Managing Director of EdiliziAcrobatica S.p.A. ("Company" or "EDAC"), has disclosed data relating to the value of production of the Company, not subject to statutory audit, and its expansion in Italy. In particular, revenues for the first quarter amounted to approximately Euro 8.3 million, up 74% compared to the corresponding figure for the previous year, equal to approximately Euro 4.8 million. As of March 31st, 2019, the direct operating offices reached 42, with an increase of 3 units compared to 39 as of December 31st, 2018. As of March 31, 2019, the number of franchised operating offices reached 32, with an increase of 1 unit compared to the 31 registered as of December 31, 2018.

Riccardo Iovino: "Growing by 74% in such a delicate moment for the economy of our country is certainly a result that comforts and stimulates us to improve further. On the other hand, perhaps one of the secrets of the success of EdiliziAcrobatica lies precisely in the fact that none of us is content with the goals we have achieved but we always set new goals to pursue.
