**EDILIZIACROBATICA: NOTICE OF ORDINARY AND EXTRAORDINARY SHAREHOLDERS' MEETING  
PUBLISHED**

**Genoa, 12 April 2021** – EdiliziAcrobatica S.p.A. (the “*Company*”) announces that on 10 April 2021 the notice convening the Ordinary and Extraordinary Shareholders' Meeting was published in the Official Gazette, Part II, no. 43.

The Shareholders' Meeting is convened in ordinary and extraordinary session on 29 April 2021 at 11 am on first call, at the Company's registered office in Genoa, Viale Brigate Partigiane 18, and, if necessary, on 30 April 2021 on second call, same time and place, to discuss and resolve on the following

Ordinary part

1. Examination and approval of the financial statements of EdiliziAcrobatica S.p.A. for the year ended 31 December 2020, including the report of the Board of Directors on operations, the report of the Board of Statutory Auditors, and the report of the independent auditors; related and consequent resolutions.
2. Resolutions relating to the allocation of net income for the year 2020; resolutions relating to and resulting therefrom.

Extraordinary part

1. Amendment of articles 3, 6, 8, 11, 14, 15, 16, 17 and 19 of the EdiliziAcrobatica S.p.A. By-laws; related and consequent resolutions.

**COMPOSITION OF THE SHARE CAPITAL AND PARTICIPATION IN THE SHAREHOLDERS' MEETING**

The subscribed and paid-up share capital of EdiliziAcrobatica S.p.A. amounts to €803,249.8, represented by 8,032,498 shares having no nominal value. At the date of this notice the Company does not hold any treasury shares in its portfolio.

Pursuant to article 83-*sexies* of Italian Legislative Decree no. 58/1998 (the “*TUF*”), entitlement to attend and exercise the right to vote at the shareholders' meeting is vested in the shareholders from whom the Company has received – by the end of the third trading day prior to the date set for the shareholders' meeting (i.e. **26 April 2021**) – the appropriate communication issued by the authorised intermediary that certifies their entitlement based on its accounting records. The right

to attend and vote remains valid if this communication is received by the Company after the above deadline, provided that it is received by the beginning of the individual meeting.

The communication is issued by the intermediary based on the evidence in the accounts relating to the end of the accounting day of the seventh trading day (the so-called "record date") prior to the date set for the shareholders' meeting (i.e. **20 April 2021**). Credit or debit entries made in the accounts after that period do not count towards entitlement to exercise the right to vote at the shareholders' meeting.

## ORGANISATIONAL ASPECTS OF AND REPRESENTATION AT THE SHAREHOLDERS' MEETING

Considering the current epidemic and the national and regional measures that for various reasons have established limitations on the physical presence of more than two people in the same place, pursuant to the provisions of article 106, paragraph 2 of Decree-Law no. 18/2020 (the "***Cura Italia Decree***"), attendance at the meeting by those who have the right to vote will take place exclusively by means of remote participation through video conference at the addresses that will be provided to all persons entitled to attend the Shareholders' Meeting (Chairman, Notary, members of the Board of Directors and the Board of Statutory Auditors and registered Shareholders) or authorised to participate by the Chairman (e.g. Company employees and contractors).

In order to receive the access codes to the Company's platform to participate in the video conference of the shareholders' meeting, each Shareholder must email the Company (i) a copy of the certificate of participation in the shareholders' meeting issued by the intermediary attesting – based on the evidence resulting from the accounting records relating to the end of the record date (20 April 2021) – entitlement to attend the shareholders' meeting (the "***Certificate***"), as well as (ii) a copy of the Shareholder's identity document (identity card or passport). If the Shareholder is a legal person, along with the Certificate the Shareholder must email the Company (i) a copy of the identity document (identity card or passport) of the legal representative or of the person having the necessary powers to participate in the meeting, as well as (ii) a copy of the documentation certifying the legal representation or the granting of such powers to the participant.

The documentation required for participation must be submitted by email to [edilziacrobaticaspa@pec.it](mailto:edilziacrobaticaspa@pec.it) no later than 6 pm on the day before the date of the first convocation of the meeting in order to allow the Company to authorise the related shareholdings.

Note that the Company will communicate the platform access codes for participation in the video conference of the shareholders' meeting only after verifying the entitlement to participate based on the documentation submitted according to the aforementioned method. Otherwise, connection and participation in the meeting will not be permitted.

Without prejudice to the method of participation by means of video conference, pursuant to the law and article 14 of the Company's By-laws any shareholder who has the right to attend the meeting may be represented by written proxy in compliance with the provisions of article 2372 of the Italian Civil Code, using the proxy form available on the Company's website at [www.ediliziacrobatika.com](http://www.ediliziacrobatika.com) in the "Investor Relations" section. The proxy may be sent to the Company by registered mail to EdiliziAcrobatica S.p.A., Viale Brigate Partigiane 18, 16129, Genoa, or by email to the certified email address [ediliziacrobatikaspa@pec.it](mailto:ediliziacrobatikaspa@pec.it).

To exercise the rights to add items to the agenda and to ask questions before the meeting as envisaged in article 13 of the By-laws, please refer to the text of the By-laws published on the corporate website at [www.ediliziacrobatika.com](http://www.ediliziacrobatika.com) in the "Investor Relations" section.

It is recommended that Shareholders comply with the methods of participation detailed in this notice since physical participation in the meeting is not practicable under the current requirements and limitations established by national and regional provisions related to the national health emergency.

Founded in Genoa in 1994 by Riccardo Iovino, the company now has over 1,000 employees and 100 operating areas in Italy and France. The technique it employs allows working without scaffolding or aerial platforms, thus offering end customers a quality service and the elimination of scaffolding costs. The rope access that EdiliziAcrobatica is specialised in is particularly well suited to ordinary and extraordinary maintenance of buildings and apartment complexes, hotels and historical monuments. In fact, the technique developed by EdiliziAcrobatica ensures numerous benefits both in terms of accessibility for apartment complex residents and hotel guests and safety for tenants and access to monuments that always remain accessible even during restoration and maintenance works.

Listed on the AIM Italia stock exchange since November 2018 and on the Euronext Growth market in Paris since February 2019, EdiliziAcrobatica closed 2020 – the year of the pandemic and the stoppage of construction sites – with €44.8 million in revenues, up 14% compared to 2019. During the year the company also inaugurated a new business line dedicated to cleaning and disinfection and released EAcondominium, the first app in Italy for condominium administrators to facilitate the holding of remote tenant meetings.
