**EDILIZIACROBATICA: A RECORD AUGUST
WITH CONTRACTS UP +419%**

Genoa, 15 September 2021 – EdiliziAcrobatica S.p.A. closed the month of August 2021 with another exceptional result, an increase of **419%** in contracts signed – **equal to €8,368,000** – compared to the €1,611,000 of 2020.

The company's progressive growth is also evident in the figures of the first eight months of the year compared to the same period of last year. Indeed, the value of the contracts signed, amounting to €80.7 million, is up around 310% compared to €19.7 million in 2020.

Moreover, the group reached a total of **1,245** employees at 31 August 2021 compared to 931 at 31 August 2020, equal to an increase of 33.73%.

EdiliziAcrobatica France reported positive results that brought the value of production in August 2021 to €255,624, equal to +47% compared to the same month of 2020 when it had been €173,997.

Riccardo Iovino, CEO & Founder of EdiliziAcrobatica, commented, "The growth that has characterised 2021 to this point continues and indeed improved, even in a month like August that's normally not very busy for the construction business. It's one more reason to continue working as we always have, looking optimistically towards the upcoming fall season".

EdiliziAcrobatica SpA is the leading company in Italy in the construction sector operating with double safety ropes. Founded in Genoa in 1994 by Riccardo Iovino, the company now has over 1,200 employees and 100 operating areas in Italy, France and Spain. The technique it employs allows working without scaffolding or aerial platforms, thus offering end customers a quality service and the elimination of scaffolding costs. The rope access that EdiliziAcrobatica is specialised in is particularly well suited to ordinary and extraordinary maintenance of buildings and apartment complexes, hotels and historical monuments. In fact, the technique developed by EdiliziAcrobatica ensures numerous benefits both in terms of accessibility for apartment complex residents and hotel guests and safety for tenants

and access to monuments that always remain accessible to tourists even during restoration and maintenance works.

Listed on the AIM Italia stock exchange since November 2018 and on the Euronext Growth market in Paris since February 2019, EdiliziAcrobatica closed 2020 – the year of the pandemic and the stoppage of construction sites – with €44.6 million in revenues, up about 14% compared to 2019. During the year the company also inaugurated a new business line dedicated to cleaning and disinfection and released EAcondominio, the first app in Italy for condominium administrators to facilitate the holding of remote tenant meetings.
